#### FOR CONSIDERATION

PWC Report, Legal Aid Funding: Current Challenges and the Opportunities of Cooperative Federalism – Key Campaign Objectives – 2012/2013 Budget.

The President noted that the Law Council has called on constituent bodies to take up the principles set out in the Key Campaign Objectives. The Bar Council <u>RESOLVED</u> to adopt the principles in the LCA statement. The focus of the principles is on the restoration of Commonwealth legal aid funding to a 50% share with the States and Territories. The LCA is planning to hold a forum on Commonwealth/State legal aid funding and proposes to invite all State and Territory Attorneys General and their Shadows to attend. The Legal Aid Committee was considering these issues and will develop appropriate proposals for the consideration of Bar Council.
