"Proximate Cause, Perils of the Sea and Inherent Vice in Marine Insurance"

The Honourable Mr. Justice Allsop, President of the Court of Appeal, will focus on two aspects of causation in marine insurance. First, the nature of the causal question in the context of marine insurance, having considered academic debate, statutory developments and judicial approach to questions of causation generally. Secondly, the presentation will canvas the intersection between inherent vice and perils of the seas for the purposes of determining the proximate cause of loss. This will be undertaken in light of the recent decision of the Supreme Court of the United Kingdom: *Global Process Systems Inc v Syarikat Takaful Malaysia Berhad* [2011] UKSC 5.
