Each July, barristers wishing to be appointed Senior Counsel apply to the President of the Bar Association for consideration. Their applications are then considered by the Selection Committee, who take into account the views of a large number of barristers, solicitors and members of the state and federal judiciary.

Peter John McGRATH

Crown Prosecutors Chambers - Sydney

Peter commenced his legal practice as a solicitor in October 1984 before coming to the NSW Bar in August 1990. He was appointed a Crown Prosecutor for the State of NSW in January 2012, having acted in that position since September 2010. Peter practises principally in the areas of criminal law, commissions of inquiry and coronial inquests. He also runs serious and complex criminal trials and sentence proceedings before judges and juries in the NSW District and Supreme Courts. Whilst at the Bar, he has overseen the criminal reading component of the Readers Programme. He has also participated in the mentoring and advice scheme run by the Aboriginal Legal Service. Ian has been practising as a lawyer since 1985 and came to the NSW Bar in 1993. He has developed a broad practice in a variety of areas, focusing in particular on criminal prosecutions, administrative law appeals in the Supreme Court, coronial inquests, commissions of inquiry, disciplinary proceedings and care proceedings/appeals concerning children. His practice involves a significant proportion of appellate work, in the Supreme Court and also in the Court of Criminal Appeal and Court of Appeal. He is a current member of the Bar Association's Criminal Law Committee and the Legal Aid Review Committee [Barristers' Admission Board DipL; LLM (University of Sydney)]

Rashda Parveen RANA

Rashda has been practicing as an advocate for over 20 years in London and also in various states in Australia (primarily in NSW). She came to the NSW Bar in 1994.
