Instrument of Delegation

This instrument takes effect on 1 December 2025.

In this instrument:

- (i) Terms used in the *Legal Profession Uniform Law* (NSW) (***Uniform Law***) or in the *Legal Profession Uniform Law Application Act 2014* (NSW) (***Application Act***) have the same meanings in this instrument as they have in those laws.
- (ii) “**Commissioner’s functions**” means the functions delegated to the Bar Council under the *Uniform Law* by the NSW Legal Services Commissioner by Instrument of Delegation dated 6 March 2024, subject to the direction issued by the Commissioner in that instrument.

Pursuant to section 30 of the *Application Act* and section 406 of the *Uniform Law*, the Bar Council hereby delegates to the committees, officers and employees identified in Column C, and any member of the staff of the Bar Association acting in those roles from time to time, the functions, including the Commissioner’s functions, in Columns A and B, subject to the restrictions in Column D:
